

Uniform Player Contract

Entered into this	day of	, 20	between the parties whose sign	gnatures appear below, the first
hereinafter known as "Tea	m,," the second hereinafte	er known as "Player	" and the third being the NBC	Baseball Foundation dba
National Baseball Congres	s ("NBC").			

It is understood between the parties hereto that mutual promises of each party to this agreement shall be full and complete consideration for this contract.

Player agrees that he will, for a period following date hereof, be a member of Team for the entirety of the Summer 20__ season, unless said player may be released from Team as hereinafter provided.

This agreement may be terminated at any time by an authorized official of Team, in his or her sole discretion, and Player may be released by Team filling out and delivering, by electronic mail, facsimile, or overnight delivery, to NBC a completed release form. Upon receipt of said release, NBC will notify Player that he is a free agent for the remainder of the Summer 20__ season and shall provide Player a signed copy of his release. Until Player receives a signed copy of said release from NBC, he is not eligible to play for or practice with any other NBC-affiliated team.

This agreement may be executed in one or more counterparts, all of which taken together shall constitute one instrument. Copies of the agreement (including faxed, emailed and/or other electronic copies) shall be accepted as originals. Upon receiving a fully executed agreement, NBC shall first check player's eligibility status and, if eligible, then certify him for play.

By signing below, Team certifies to Player and to NBC that Team adheres to the NCAA Summer Baseball Eligibility Rules, and further certifies that no player on Team receives any financial remuneration from or on behalf of Team, its sponsors or boosters, except that which is allowed under NCAA rules. In the event Player affiliates with another NBC team without having been properly released from this agreement or Team affiliates with a player while knowing he is not a legal free agent, will subject the violating party to a two-year suspension from participating in any tournament or league affiliated with NBC. It is further understood that any NBC affiliated team may protest the eligibility of any NBC player in his league or any NBC sanctioned tournaments. Any team protesting a player's eligibility must post a \$50.00 bond at the time of protest. If protest is allowed this bond will be promptly returned.

This Agreement shall remain in effect through the conclusion of the 20 NBC World Series.
